THE MISSION SUPPORTS A FRACTION OF ITS PROGRAMS AND SERVICES FROM STORES REVENUE GENERATED FROM DONATED CLOTHINGS AND HOUSEHOLD GOODS AT ITS 13 ATTENDED DONATION CENTERS (ADC'S). HOUSEHOLD GOODS AND CLOTHINGS DONATED AT THE ADC'S ARE STORED AT THE ORGANIZATION'S REDISTRIBUTION CENTRE WHICH ARE SUBSEQUENTLY OFFERED FOR RESALE AT THE STORES. RESCUE MISSION SOCIAL ENTERPRISE OPERATIONS ALSO PROVIDE EMPLOYMENT OPPORTUNITES IN AUBURN, BINGHAMTON, ITHACA AND SYRACUSE AREAS.

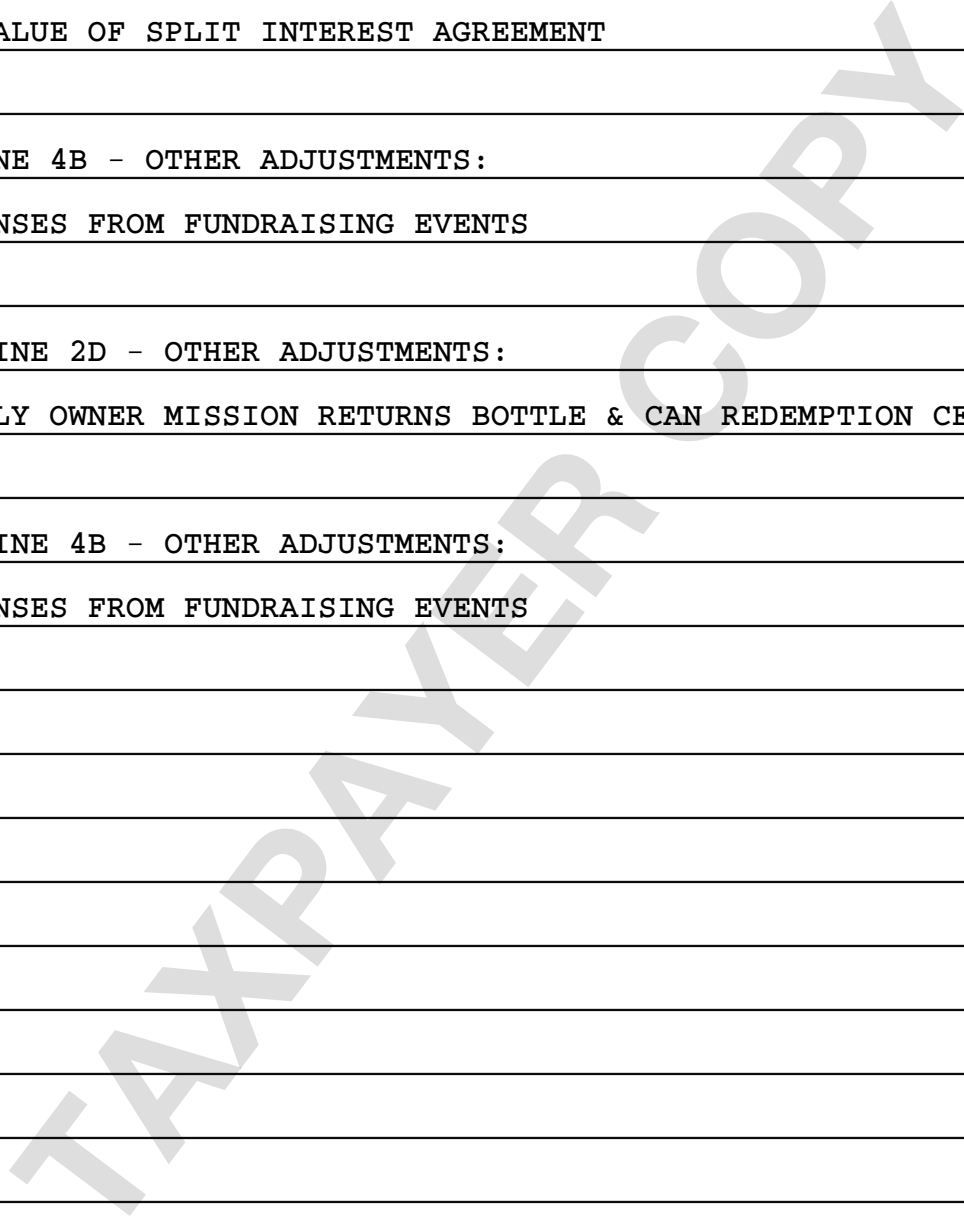
